## **Fall 2019: \$1,000 Manulife Place Shopping Spree**

### Contest Rules & Regulations

1. The 2019 Manulife Place Fall '\$1,000 Shopping Spree' will run from Friday, October 25, 2019 to Tuesday, November 12, 2019.
2. Residents of Alberta, 18 years of age and older may enter, except employees and immediate family members (and/or persons domiciled with employees) of Manulife and Manulife Investment Management and the owners and co-owners of Manulife Place, and affiliated companies and their advertising agencies (collectively, the "Sponsors").
3. Each individual may enter the contest via original contest entry ballot available at participating Manulife Place retailers. To receive one (1) entry ballot, each participant must make a minimum purchase of \$200 CAD before taxes. Each participant may receive one (1) entry ballot per \$200 before tax spent at participating Manulife Place retailers. Each participant may enter the contest as many times as is equal to the number of entry ballots they receive according to minimum purchase regulations.
4. All entry ballots must be submitted to a participating retailer by 5:30 p.m. MT on Tuesday, November 12, 2019.
5. One prize will be awarded. The prize is a \$1,000 CAD Manulife Place gift card which can be used at any participating Manulife Place retailer, which is referred to as the "Prize" in the rules and regulations. The Prize may not be sold and is not convertible to cash.
6. The winner of the Prize will be selected in a random drawing conducted at the property management office of the property, also known as Manulife Place, located at 10180 101 Street at 12:00 p.m. MST on Friday, November 15, 2019 from all eligible entries received by the contest closing time. Entrants do not need to be present to win. Property Management will attempt to notify the selected entrant by the phone number or e-mail address provided on the entry ballot on Monday, November 18, 2019. In the event that the selected entrant cannot be reached by November 20, 2019, another entrant will be selected. Upon contact, the selected entrant will have until December 31, 2019 to pick-up the Prize.
7. To claim the Prize, the selected entrant must present a valid form of government identification and must answer a skill-testing question, determined by the property management team at Manulife Place.
8. The chances of an entry being drawn depend on the total number of entries received at the time of the draw.

The selected entrant must grant a full and final release, remise and discharge to the Sponsors and each of their directors, officers, employees, representatives, agents or affiliates (collectively the "Releasees") from all obligations, representations or responsibilities with respect to the Prize, including, without limitation, any injury, accident, loss of life or other misfortune relating to or emanating from the Prize.

The Sponsors reserve the right in their sole discretion to disqualify any individual they find to be tampering with the operation of the Contest or to be acting in violation of these rules or otherwise in disruptive manner with respect to the Contest. 11. The Sponsors will be collecting data about entrants through the Contest entry process. Any personal information will be handled in accordance with the privacy policy of Manulife Investment Management.

By entering the Contest each entrant consents to the collection, use and distribution of his/her personal information (information that identifies an entrant as an individual, such as home telephone number, age and home address) by the Sponsors for the purposes of implementing, administering and fulfilling the Contest.
